I. Background

The Higher Education Improvement Project (HEIP) was approved by the World Bank on April 26, 2018 and became effective on 17 September 2018. The HEIP activities are funded by an International Development Association (IDA) Credit of US\$ 90.0 million equivalent and US\$2.5 million from the Royal Government of Cambodia. It is expected to be implemented over a 6-year period starting in July 2018 and ending in June 2024. The project aims to strengthen higher education systems and support the development of legislation for autonomous HEIs. The project is now seeking a Technical Assistant to Implement STEM Education Local Partnership at (RUA).

II. Contract Duration

The consultancy service is for 18 months. The contract may be extended depending on the needs of the project, performance of the consultant and availability of funds.
